# From Homeless to a Home

For over 50 years the Council on Aging has been serving senior residents of St. Clair County, 60 and over, with such services as providing transportation to and from medical appointments, senior nutrition services such as meals on wheels, personal care, help with chores and home repairs. They also have four senior centers that provide socializing opportunities, crafts and exercise programs. Sometimes, the council on aging has the opportunity to really help an area senior in a big way with a major life change. That is exactly what happened with a local area senior who is 78 years old and was homeless.

Cheryl Kelly who works for the downriver Council on Aging, had received a call one day from a gentleman who was looking for some help. He was staying at a hotel downriver and was looking for some food. Cheryl went to visit the man and in talking to him, she learned his story. He was a homeless senior who had been homeless for sometime. He had been in and out of the hospital for various health issues and had just recently gotten out of the hospital and was fortunate enough to have received a room at the hotel for about 3 or 4 nights from some very caring individuals. He had disclosed to Cheryl that he had one night left at the hotel and then he was going to go back to the bench at the park to stay. This didn't sit well with Cheryl and she told him she would be in contact with him soon. She went straight back to her office and contacted Mary Taylor who is the Assistant Director of the Council on Aging. She told Mary his story and said they had to find a way to help him! Mary reached out to Amy Smith of the St. Clair County Community Mental Health agency who said they had no shelters available for him downriver but suggested that they contact Sanborn Gratiot Memorial Home as they have some beds that are set aside for homeless seniors. They contacted Kathy Baker at Sanborn who told them that all of their beds designated for homeless seniors have been filled, however she was determined to help this man as well and she Continued on page 2


Contacted Jenny Posey at the Council on Aging to ask if there were any extra millage dollars set aside to help this man have a bed at Sanborn temporarily until a permanent home could be found for him. Cheryl and Mary were working on finding him permanent residence and they were able to find an apartment for him, however it wouldn't be ready for him to move into for a month and nobody wanted to see him staying at the park and not getting the proper medical attention that he needed.

The good news came in and a 5th bed for homeless seniors was approved through the millage dollars and he was able to move into Sanborn Gratiot Memorial home where he had a warm bed to sleep in, meals provided for him and people around the clock to care for him!

This is not the end of this story however. As stated above, Cheryl was able to find him an apartment that he moved into in mid July. Not only did they help him find his own fully furnished place, they helped him set up all of his utilities, move his medical doctors from Macomb County to St. Clair County, set him up with food pantries and for their programs they offer such as meals on wheels and transportation to all of his appointments whenever he needs to go. Cheryl was able to go to Harbor Impact Ministries and Barb the director there helped her go through all of their donations to get the things he would need for his own place. What they couldn't find there, they were able to ask the public for donations. The public donated everything else he needed to live independently. Right down to a shower curtain!

Cheryl said that all he kept saying was that he couldn't believe how nice and generous everyone had been to him. This story is just one of many stories involving seniors in our community who need help. Not only with the big things such as this, but with little things like household chores, repairs, rides to appointments, food, socializing and friendship. We are so very grateful we have the Council on Aging in our community. Thank you Cheryl for your compassion and determination to help not only this man, but all those that you and the rest of the Council on Aging staff and volunteers help on a daily basis!
